Every year the Music Program takes its many talents on the road. This year the music program will travel to Orlando, Florida to participate in the Fiesta-Val Music Festival. The trip is scheduled for Wednesday, April 9, 2008 (after school ends) through Sunday, April 13, 2008. As you can imagine, an overnight trip involving over 200 students is an incredible task. However, with the proper planning and support, these trips provide growth experiences that students remember for the rest of their lives.

As you know, fundraising is done throughout the year. The RHHS Music Boosters, Inc. sponsor fundraising events. Students are invited to participate in these fundraisers, with a percentage of the profit going to an individual Student Account. These funds may then be used to off-set the cost of the Spring Adjudication Trip. Several fundraisers have already taken place. Student Account statements will be distributed to students in November. Outstanding balances on Student Accounts must be satisfied before the first payment will be accepted. Cost

The cost of the Spring Adjudication Trip will be approximately \$625. The actual cost will depend on the number of participating students and will be finalized after receipt of deposits.
